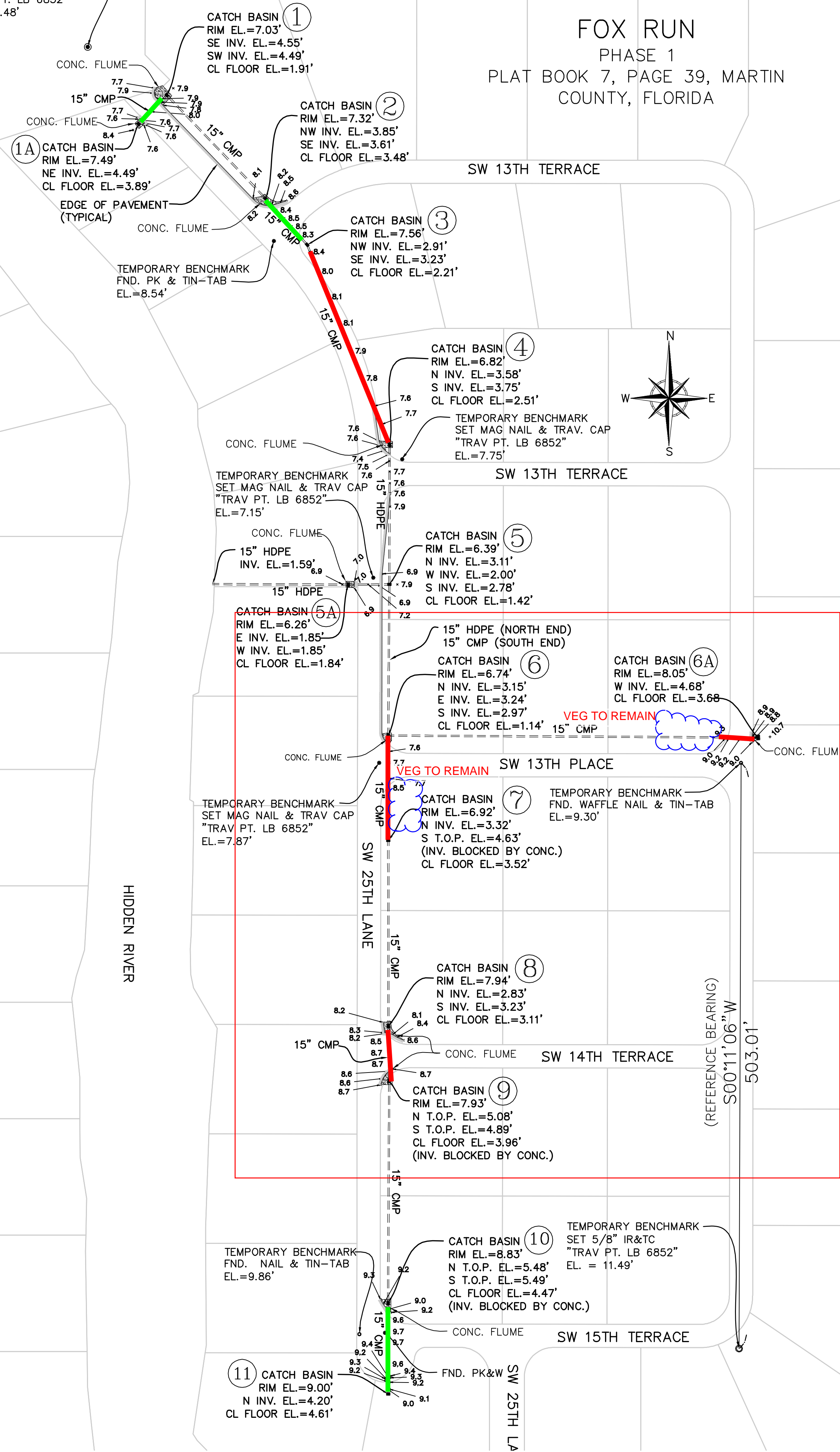
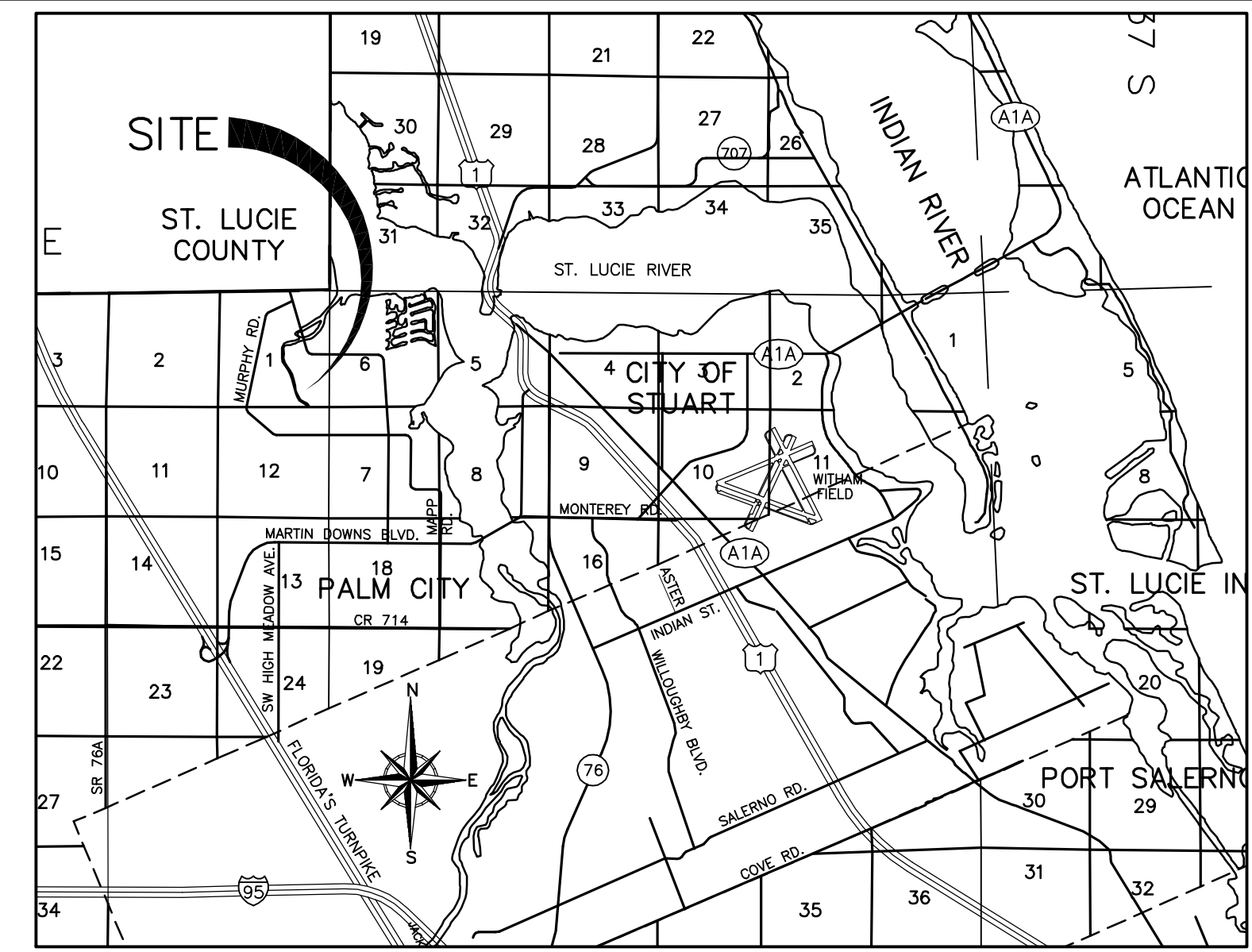


TEMPORARY BENCHMARK

1. BEARINGS AS SHOWN HEREON ARE BASED ON STATE PLANE COORDINATES, NORTH AMERICAN DATUM OF 1983 (N.A.D. 83), FLORIDA EAST ZONE, REFERENCE A BEARING OF S00°11'06"W ALONG A LINE BETWEEN TWO ONSITE TEMPORARY BENCHMARKS.
2. ELEVATIONS AS SHOWN HEREON REFERENCE THE NATIONAL GEODETIC VERTICAL DATUM OF 1929 (N.G.V.D. 29), REFERENCE MARTIN COUNTY BENCHMARKS "BESSEY-1" ELEVATION = 8.915 FEET AND "MMM-1", ELEVATION = 12.836 FEET.
3. THIS SURVEY WAS DONE WITHOUT THE BENEFIT OF A TITLE COMMITMENT.
4. THIS SURVEY IS BASED ON A CLOSED GEOMETRIC FIGURE EXCEEDING A HORIZONTAL CLOSURE OF 1:10,000.
